

INTRODUCING A MAJOR NEW HOSE SERVICE

TANK TOP SAFETY

As some of you will know, the **HSE** is re-launching their **“Prevent falls from vehicles”** campaign, and this topic is obviously now a major concern to the HSE. Their website quotes figures of 1600 injuries and 4 fatalities last year as a result of falls from vehicles.



One of the points in the HSE campaign is that when a vehicle is being specified, it is most important that serious consideration is given to the prevention of falling. Of course, many operators already do this, and as you can see from the photograph, this operator has shown that he takes tank top safety very seriously. This is not a new tanker, but one which we have completely refurbished and repainted as well as fitting the “boxing ring” safety rails. The power pack is a reconditioned unit supplied and fitted by ourselves.

Although one usually thinks in terms of falls from the top of a tanker, which obviously can be fatal, other less serious accidents occur when the **driver has to climb on to the tractor chassis** to connect/disconnect the airlines etc. To overcome this problem on tankers, we have designed a **pivoted beam** that carries the connections and this can be swung to the side of the chassis for connecting and disconnecting the couplings. In this way, **the driver does not need to climb on to the tractor**.

This photograph shows the connection bar lowered and it is then swung through 90 degrees so that it travels in the vertical position. We have had one on test for a while and a **major operator is now having all his trailers fitted** with this device when they come in for repainting.
